Pilot ladders with:

- seizing system solution 1
- seizing system solution 2
- mechanical clamp system / ferrules

Side ropes of ≥20 mm diameter are made of mildew-resistant manila or sisal rope meeting ISO1181:20004, Quality 1 requirements.

Steps are made of hardwood (beech) and rubber.

Steps: 6 - 72

Length: max. 25.20 metres

Application/Limitation

This examination has only considered the pilot ladder and not the installation arrangement.

The installation to be approved on board.

Handholds shall be provided to ensure a safe passage to and from the pilot ladder.

The maximum length of the pilot ladder shall not exceed 25.20 metres in total (72 steps).

Each rope shall be continuous with no joints below the top step.

The design assessment is based on ISO799-1:2019(E).
